



When I heard the Science Council talk about professional registration, I was inspired

Professional registration via its Employer Champion programme offers, I discovered, a 'one-stop shop' that streamlined the process. Myself and my colleagues decided to work towards Employer Champion status – and received the award in October 2016, Senior Vice President Professor Sir Robert Lechler, King's College London, was the key note speaker co-hosted by the Science Council. Over 120 members of staff attended, and the Science Council have continued to offer great support in person and online ever since.

Senior leadership were so impressed that they funded professional registration for all staff who wanted to become professionally registered. This support kickstarted the registration programme at King's College, and in the first year 60 of our people registered.

Staff morale has risen significantly

Achieving professional registration has given staff confidence to meet colleagues from other labs and faculties, and created a culture of collaboration. In fact, today there's a network of over 400 technicians who share ideas, equipment, best practice as well as meetings, workshops and social events. We have a monthly away day and senior leadership attend. The network is so active it is recognised as the largest and most active in the University.
